The Appointment process for the next Bishop of Warrington

As you now know, Bishop Bev has resigned from her post as Bishop of Warrington which takes effect from 30th September. This means that we now initiate the process of appointing a new bishop to this See, as agreed by the Dioceses Commission in the submission made to them re. the appointment of an Interim Bishop of Liverpool.

Archbishop Stephen and I had a conversation about the appointment last week, in which he reiterated his support for the process to begin immediately under my leadership. The reason for this is that as a diocese we have been effectively without a suffragan bishop for the past two years. I am conscious that the process for the Vacancy in See is also beginning to come into effect at this time but rather than delay, the appointment now of +Warrington enables the continuity of effective episcopal leadership for the diocese at a vital point in its strategic mission and ministry.

Consultation has also taken place with Stephen Knott and Helen Averill of the Archbishops' Advisers for Appointments and Vocations team, and we are now at the point of agreeing a possible timetable for the process. (See below)

The first step is for us to agree that we require a bishop of Warrington, to agree the process as outlined, and to prepare a submission to the national Dioceses' Commission who make the decision that a diocese can proceed to appointment.

<u>ACTION</u>: The Bishop's Council, on behalf of the Diocesan Synod, to agree that we require a bishop of Warrington and that we initiate the process according to the timetable as outlined.

The Advisory Panel:

Suffrgan bishop appointments are made by the Diocesan Bishop (and in this case in close consultation with Archbishop Stephen). All such appointments are supported by the valuable input of an advisory panel. It is important that we have a small panel which is representative of the diocese and reflects its diversity. Advice as to its shape and who should or should not be part of it is offered by the AAAV.

<u>ACTION</u>: +Ruth, consults with the Dean, Archdeacons, Diocesan Secretary, Chairs of the Houses of Clergy, Laity and Trustees, to form an Advisory panel who will work with her to agree the submission to the Dioceses' Commission and advise on the appointment. A report will be made to the Diocesan Synod on October 11th.
