

Memorandum of Understanding for School/Trust and Worship Community

The Bigger Picture

General Synod 2019 set a vision to change the culture of the Church of England "so that every aspect of Mission and ministry is seen through the lens of what it means for ministry with children, young people and households."¹

Liverpool Diocese is committed to being a Bigger Church making a Bigger Difference, more people knowing Jesus more justice in the world.² With 4 missions priorities which are foundational to this vision:-

1. Introducing people to Jesus
2. Depending discipleship
3. Developing Christian Leaders
4. Working for Justice

Local Context

Liverpool Diocese is blessed with great relationships between schools/trusts and local churches, all wanting to serve the spiritual needs of their community. Many churches and schools/trusts are committed to Growing Faith.

Where Directors/Governors and PCC agree then starting a New Worship Community (NWC) in a school is one way of fulfilling the Bigger Picture.

Partnership aims/objective

The aim of a NWC is to offer a worship community that will be enriched by spiritual encounters, through the sharing of personal stories and developing imaginative practices, that help make faith relevant to all. It includes mission, discipleship, leadership and worship; this will be led by the local church and embedded as an integral part of wider parish life.³

All NWC leaders will be Safer Recruited. All NWV leaders at all times will hold an in-date DBS and have attended safeguarding training.
